Brother Hermann's Life of the Countess Yolanda of Vianden Apr 25 2022 First translation into English of the medieval German *Leben der Graefen Iolanda*, making it accessible to a wider audience. Brother Hermann was a cleric in the region of Luxembourg in the last quarter of the thirteenth century; evidence from his *Life of the Countess Yolanda* suggests that he was a Dominican with, perhaps surprisingly, knowledge of the Middle High German courtly epic and the poetry of other contemporaries such as Walther von der Vogelweide. The *Life*, written shortly after Yolanda's death in 1283, concentrates on her struggle from childhood to free herself from secular society, principally by avoiding a contracted marriage, and to enter the cloister of Marienthal, of which she became Prioress. Although Brother Hermann's epic is hagiographic in tone, the fact that he wrote it in German, not based on a Latin *vita* suggests that he did not regard Yolanda as a candidate for sainthood; his heroine's attempts to find fulfillment have a strong contemporary resonance. Professor Lawson's translation, the first ever into English prose, makes this work accessible to a more general readership.

Manual of Patrology Sep 06 2020 This little book, by a German Benedictine Father, is intended as nothing more than an "introduction" to the knowledge of the Fathers of the Church. It might be called a "handy-book" to the great collection of writers whose works appear in the "Cursus Patrologiae." No student has any chance of thoroughly mastering the whole of the three or four hundred volumes of Migne's edition. But, on the other hand, no one can pretend to a scientific knowledge of divinity, unless he has read the Fathers to some purpose. Students, therefore, whether those who are passing through their course in 11. seminary, or those who, in more mature years, are following up some portion of the Church's great doctrinal inheritance, will always find a use for a small and well arranged guide to the epochs, the authors, and the subjects of patristic literature. An acquaintance with the writings of the Fathers of the Church is useful to students of theology on many heads. First, to be tolerably well read in the Fathers is to know theology in its historical aspect. No man ever possesses a true knowledge of things that have grown, unless, to a certain extent, he can trace the process of their growth. To understand, in all its circumstances and surroundings, the development of anyone dogma, is a splendid training in scientific theology. To appreciate what it was in the past, and in the actual circumstances that made St. Augustine defend with such amplitude and determination his views of grace and predestination, which, nevertheless, as he said, had always been held by the Church of God; to see with your own eyes in the pages of Athanasius and Hilary, how the terminology of the doctrine of the Blessed Trinity becomes distinct and clear-cut; to feel the tremulous and indignant emphasis which Leo puts in his oft-repeated formula of the Word made flesh; to follow Cyril of Alexandria through the thicket of his earnest speech, and recognize at every turn the traces of an adversary who is intent on denying to Jesus Christ bis eternity and his divinity - this kind of study is a very different thing from learning formularies by heart, or getting up patristic texts in compendiums. Moreover, it is from the study of the Fatbers that modern theology derives what I may call its elasticity. This is an age of manuals, abstracts, catechisms, and other apparatus for accomplishing the process which is known as "cramming." Education conducted on principles of this kind can never become part of one's mental, and spiritual life. The knowledge thus gained lies in the receptive power like a stone on the surface of a field; whatever crop the field grows, the stone has no

share in fertilizing it. The Fathers did not write abstracts. They searched the Scriptures, compared testimonies, examined traditions and expostulated with false teachings. Most of them launched out from time to time into literary exposition, into rhetoric, or into poetry. A modern catechism read without the light of patristic illustration is both inadequate and misleading. When faith is described as being "to believe without doubting whatever God has revealed," the patristic student thinks of the long centuries, full of intellectual activity, during which that august word has been invoked, written about, defined, divided, lifted up, trampled upon and fought over - and he is the less likely to fancy that this definition tells him all about it. When he reads that God is the Supreme Spirit, Who exists of Himself, "he will remember, if he has read Athanasius, Hilary, and John Damascene, how the Greek and Latin intellect have striven to put into philosophic language the revelation of God's Name, I am Who am." The formularies say with easy consciousness that man was "made to God's image and likeness;" the Fathers have discussed from a hundred points of view what this divine revelation means.

The New Parish Priest's Practical Manual Apr 06 2023 BEING now thirty years a Parish Priest, although in many things, and even in all, I may be deficient in speculative science, I think I can no longer fail in matters of practical knowledge; and, moreover, having discharged the duties of this office for upwards of seven years in a suburban parish, which embraces both town and country, my experience may prove of some value for country, town, and city parishes. Beyond this, I put forward no other claim. to justify my project of publishing this "Practical Manual." I present it to new Parish Priests with the freedom of an elder brother, who can say to them: You, fresh from your studies, surpass me in theoretical science; but, in practical matters, I must, of necessity, have an advantage over you. Nevertheless, I shall never rely on my own individual judgment. I promise to put forward nothing which has not the approval of persons more intelligent and more experienced than myself; and this resolution, which with God's help I will not change, gives me great ground for hoping that, even should I fail in accomplishing any considerable amount of good, at least there shall be no danger of my doing any harm. I must not omit to mention that, some days after I had conceived the idea of composing this work, and had written barely a few pages of it, one of the brightest lights of our Episcopate was good enough to suggest to me the identical plan which I have followed in this Manual, exhorting me at the same time to commence it; and this fact, necessarily, encouraged me to complete the task which I had just begun. I shall divide this Manual into Three Parts. In the First, I shall treat of the duties of a Parish Priest, with the exception of those which have reference to the administration of the Sacraments, which will form the subject matter of the Second Part.

In the Third Part, I shall speak of. the practice of those virtues which are most necessary to a Parish Priest.

Trust Protectors: A Practice Manual with Forms May 15 2021 The trust protector is generally regarded as a relatively new position in trust law, and the key feature of the position is that the protector may be granted powers over the trust, which are generally superior to those of the trustee. This places the protector in a position where, by the exercise of his powers, he can cause the trust to adjust to unforeseen changes or new conditions without the need for court action or beneficiary approval. This work takes the firm position that, with only limited exception, the role of the protector is a fiduciary one, imposing on the protector a duty to act in the best interests of the purposes of the trust and the beneficiaries. Unfortunately, a substantial segment of the legal community, as well as the legislative bodies of a number of international jurisdictions, have taken a position that the protector is not a fiduciary, or that he may be declared in the trust not to be a fiduciary, and that the power granted him under the trust may be declared to be personal powers, whether or not such is the case, and thus he would have no liability for his actions or inactions while serving as protector. This "attraction" of providing total exculpation of the protector has effectively engendered a quick acceptance of the position by the bulk of the legal community and even by the legislatures of a number of jurisdictions, though almost totally unsupported by relevant case law. As a result, we have been seeing trusts which incorporate the use of a protector having the power to make critical dispositive and administrative decisions, as well as extensive modifications to the trusts without being exposed to liability for negligence or bad decisions which result in damages. This work will examine in detail the role of the protector of the trust, the relationship between the protector and the trustee, between the protector and the beneficiaries, and the protector's responsibilities to the purposes of the trust. It will demonstrate with legal support that the role of the protector is not a new role, that, in fact, the protector is simply a new name for the decades-old position of trust "advisor," and that the trust advisor is consistently regarded as a fiduciary in relevant treatises and has

been repeatedly held to be a fiduciary in relevant cases. The discussion will also review and analyze the historical issues and professional commentary relevant to trust law and the role of protector, as well as case decisions in various international jurisdictions which have shed light on the issues and some of the positions taken in the statutes of a number of jurisdictions in the United States and across the world. All legal aspects of the role will be examined, including the rights of the protector, the protector's relationship to the trustee, and the courts' regard for and treatment of the position. Further, the work will discuss in detail all of the practical considerations in using a protector, such as selection and special drafting considerations, the use of a protector in a foundation, and, in brief, the numerous tax issues that may apply. The conclusion will be that with only very limited exception, which will be explained, the protector is unquestionably a fiduciary, and just as a trustee, he should be held to fiduciary standards. Accordingly, while it is certainly possible to grant personal powers to an individual under a trust, those powers per se conflict with the duties of a protector. And while it is also possible to reduce the fiduciary liability of a protector to a minimum, it is not possible to eliminate it entirely, regardless of trust language attempting to do so.
